## Bioenergy World Americas 2006 Conference Delegates Form Terms and Conditions

### The Organisers / Co-organisers

### Registration

To register for the conference, the delegate must follow the sequential steps indicate below

- complete and submit by the Conference Delegates Form online available on the website [www.bioenergy-world.com](http://www.bioenergy-world.com)

- print, sign and fax the Conference Delegates Form to the organisers (delegates from South America must fax their Form to CEBI, delegates from all other countries must fax their Form to BEES)

- pay the Total Registration Fee following the procedures specified according to the country from where the delegate is reserving from.

By doing this, the delegate undertakes to pay the appropriate fee and to attend the conference.
